

DORIS L. YOUNG SCHOLARSHIP

Income to be used for scholarships for worthy children from China in order that they may attend college with the decision as to use of said monies and choice of the student to be left to the Superintending School Committee of the town or in the event they join an S.A.D., to those who serve on the Board of Directors of the S.A.D. from the Town of China. In that there is not a Superintendent or School Committee for China and China is not a member of a S.A.D., the RSU of which China is a member has delegated the administration of said school fund to the Town Office administration effective 7/1/2009.

The China School Committee established the following guidelines on August 26, 1982.

1. Student must be a resident of China and have resided there for the past seven (7) years continuously. Registering to vote, your driver's license, hunting and fishing license and your motor vehicle registration all may be used to establish your residency.****
2. *Student must be 25 years or younger.
3. Those in their first year of college - money will be payable to the school during the second (2nd) semester if still in attendance and not on academic or social probation.
4. Those beyond freshman year - money will be payable to the school the first (1st) semester if not on academic or social probation the previous semester.
5. ~~**Graduate students, other than those in five (5) year undergraduate programs, \$500 if otherwise demonstrates a qualified need of over \$2,000.~~
6. ***Limit individual awards to four (4) for undergraduate work and five (5) if graduate work is included.
7. The total amount to be awarded for the first year was set at \$20,000.00 with the stipulation that each year an amount to be awarded would be established after consulting with the firm that is in charge of the management and investment of the fund.
8. Applications are available at the China Town Office, China Primary School, China Middle School, Erskine Academy, other area high schools, and on the web at www.china.govoffice.com.
9. Applications must be submitted to: Doris L. Young Scholarship, c/o Town of China, 571 Lakeview Drive, China ME 04358 by May 1st of each year for scholarship money to be awarded for the school year starting the following September.
